## **Climate Change and Energy**

- Fossil fuels are responsible for over 80% of CO2 emissions in past decade according to IPCC
- UN Secretary General Antonio Guterres called investing in fossil fuels "moral and economic madness" and called for a swift transition to clean

## COP27

- Breakthrough agreement for 'loss and damage' fund for developing countries least responsible for global climate crisis
- No global agreement to phase out fossil fuels, however fossil fuels received most attention out of

any previous COP



## **United States**

- Passed \$369 billion in climate investments last year through Inflation Reduction Act
- Includes tax credits/other incentives for electric cars, heat pumps and clean energy
- Puts US on track to reduce emissions 40% below 2005 levels by 2030

#### 100,000 Green Jobs Announced Since US Adopted Climate Law, Study Finds





#### Potentially Induced Number of New Jobs in 2030 through the Inflation Reduction Act




#### **Cumulative U.S. Solar Installations**

## Australia

- Labor Party wins majority government ousting climate laggard Scott Morrison after 3 terms of leadership
- Passed law pledging to cut CO2 emissions 43% below 2005 levels and net-zero by 2050

## **European Union**


- Voted to ban sale of gas-powered cars by 2035
- Target to reduce emissions 55% below 1990 levels by 2030



#### Greenhouse gas emissions by sector, European Union (27)



Emissions are measured in carbon dioxide equivalents (CO2eq). This means non-CO2 gases are weighted by the amount of warming they cause over a 100-year timescale.






## **Brazil**

- Leftist President Lula da Silva ousted far-right incumbent Jair Bolsanaro
- Commitment to eliminate Amazon deforestation by 2030
- Deforestation in Brazil falls 61% in first month under new President

#### Deforestation rates in the Brazilian Amazon fell by 75% under Lula da Silva's presidency

Deforestation rates are given in square kilometres (km²) per year. Luiz Inácio Lula da Silva was re-elected to become Brazilian president for 2023.





## Colombia

- Leftist ex-rebel Gustavo Petro defeats far right contestant Rodolfo Hernandez
- Campaign promise to end new oil and gas exploration

The minister for mines, Irene Vélez, told world leaders the country will shift away from fossil

## **COP 15 UN Biodiversity Summit**

- Global agreement reached to protect 30% of nature by 2030 and \$200 billion annually to fund biodiversity protection
- Pledge to reduce subsidies harmful to nature by \$500 billion annually



## Canada

- Emissions reduction target of 40-45% below 2005 levels by 2030 and net-zero by 2050
- Have missed past 9 targets to reduce emissions

National GHG emissions (not including LULUCF) (MTCO2e\*)



## Oil and Gas Cap

- Federal government planning cap on oil and gas emission by end of 2023
- No cap on production; bulk of emissions from oil and gas comes from combustion not production



## Coal

- Country-wide coal phaseout by 2030
- Thermal coal exports to be banned by 2030



## **Transportation**

- Federal target of 100% EV sales in 2035 and 60% in 2030
- Federal rebates for EVs up to \$5000
- Less focus on public/active transit
- No rebates for e-bikes/used EVs

High frequency rail lines to be built between major

cities in Ontario/Quebec

## **Fossil Fuel Subsidies**

- Canada leads G7 countries in fossil fuel subsidies according 2018 report by Environmental Defense
- Fossil fuel subsidies between \$4.5 billion and \$18 billion in 2020
- Funding for carbon capture or cleaning up orphan wells not counted as subsidy by government
- Promise to end fossil fuel subsidies by 2023 as well as financing for fossil fuel projects abroad



## **Just Transition Act**

- Legislation that provides funding and training for workers in fossil fuel sector to transition to jobs in renewable energy
- Passed Sustainable Jobs plan in 2023



## Reforestation

- Promise to plant 2 billion trees by 2030
- So far 29 million trees have been planted in 2 years



## **Climate Financing**

- Canada pledged \$5.3 billion in climate finance to developing countries over next 5 years
- International funds to protect Amazon rainforest



## Single-Use Plastic Ban

- Canada banning some single-use plastics including grocery bags, straws, cutlery, six-pack rings
- Exports to continue until 2025



## **Fossil Fuel Non-Proliferation Treaty**

- Global treaty calling for fair phaseout of fossil fuels
- Modeled after global treaty to phase out nuclear weapons
- Signatories include 70 cities, 101 Nobel Laureates, 1800 civil society organizations, 3000 scientists/academics, 2 countries and over 580,000 individuals

## **Fossil Fuel Ad Ban**

- Fossil fuels caused 8.7 million deaths globally in 2018 due to air pollution, according to joint academic study
- Fossil fuels are a public health threat like tobacco companies, but fossil fuel companies are still allowed to advertise
- A lot of fossil fuel advertising is misleading and form of greenwashing

## **Fossil Banks**

- Banks are complicit in global climate crisis through fossil fuel financing
- RBC is biggest financer of fossil fuels in Canada; over \$263 billion since Paris Agreement was signed in 2015 according to report
- Federal government can regulate banks to require net-zero commitments align with financial contributions



## **Building Electrification**


- More and more jurisdictions passing electrification codes for new buildings
- Buildings are responsible for around 10% of emissions in Canada
- Study published in International Journal of Public Research and Health shows 1/8 cases of childhood asthma in US linked to indoor gas stoves






#### Gas bans and electrification codes in U.S.

As of Jan. 20, 2022








## Fossil fuel heating bans in the EU by 2024

## Sue Big Oil

- Legal campaign to hold fossil fuel companies liable for damages caused by climate crisis
- Fossil fuel companies have spent millions in lobbying politicians against pursuing climate policies and in shady climate-denial groups





## **Youth Climate Corps**

- National program to employ/empower youth to work on climate action projects
- Projects can focus on wildfire risk reduction, ecological restoration, energy efficiency, urban gardening and community leadership

## Is It Enough?

- Governments are still not doing nearly enough to fight global climate crisis
- CO2 emissions are still rising despite increased growth in clean energy
